#### **MEMBER SPOTLIGHT**



Donna Abramo is the Director of Human Resources & Operations at Patterson Belknap Webb & Tyler LLP, a 200 lawyer firm based in New York. Like many of us in Facilities, Donna worked her way up through the ranks over many years with the firm. She started out at Patterson Belknap about 30 years ago as a legal secretary and joined Human Resources in 1989. In 1993, she was selected to be a member of the team leading the firm's move into Patterson Belknap's current office at 1133 Avenue of the Americas, where the firm has remained for 20 years. Donna has been directly involved in office management and operations ever since. She became the firm's Director of Human Resources & Operations in 2003, overseeing not just facilities and operations, but also all human resources issues related to non-legal staff. Patterson Belknap occupies nine floors in its building, totaling approximately 220,000 square feet. The firm is currently undergoing a major renovation in place and restack. Construction began in September of this year and is expected to continue

through 2015. Donna has agreed to share her experiences on the project at one of the Council's upcoming telephone meetings.

#### What is a work related achievement of which you're particularly proud?

As I'm sure many Council members know, dealing with operations in Manhattan often presents unique challenges. I'm proud of the way my group and the firm has been able to navigate successfully such difficult circumstances as 9/11, the 2003 New York City Blackout and Hurricane Sandy. One specific achievement I'm particularly proud of, however, is that we were able to build out 220,000 sq. ft. in our current space with no change orders. In New York City, that's a big feat.

As I've mentioned, I've been with Patterson Belknap for 30 years.
